I am the co-author of the following CGE models. These have been used by and for a number of national and international organizations, some of whom are identified. They are under continuous development;

the technical documentation for these models is constantly evolving, but where technical documents are publicly available they are included in the publications list below.

Global CGE Models in GEMPACK:

Global multi-sectoral and multi-regional Models: GTAP, MyGTAP, GTAP-SC, and ImpactECON supply chain model (IE-SC)

The GTAP model is widely used for analysis of trade and domestic policy issues by many academics and institutions worldwide. According to google scholar there are 13,000 papers referring to the GTAP model worldwide.

The MyGTAP model is a new extension to the GTAP model, developed with Peter Minor, which allows for more detailed analysis of a particular country. It is currently being used in several policy papers related to Africa and the USA and has been incorporated by the LEI Wageningen UR, The Netherlands into their global model, LEITAP.

The GTAP-SC model was developed as part of a project for the Asian Development Bank to model global supply chains. A global supply chain database was also developed. This model has been further developed into the ImpactECON supply chain model (IE-SC)

Dynamic Models: GDyn and various versions of ImpactECON dynamic model (IEDyn)

The Dynamic GTAP model, developed with Robert McDougall and Elena Ianchovichina, can be used for analysis of foreign capital ownership and has being used extensively in the analysis of climate change and environmental issues.

The ImpactECON version includes unemployment, multiple labor categories, distinction between new and old capital and endogenous income elasticities. There is also a version that includes supply chains and willingness to pay theory.

Migration Models: GMig2 and GMig2Dyn

The GMig2 model developed with Amer Ahmed and Alan Winters has been used by the Inter-American Development Bank, the CATO Institute, the Japanese Cabinet Office (ESRI) to examine migration issues in the Americas and Asia. The dynamic version (GMig2Dyn) is a newly developed version with Angel Aguiar that has been used extensively to examine US immigration policy with regards to legal and illegal immigrants. Research using these models has been cited by The Economist, Washington Post, Manila Press, Radio Australia and in reports to the Australian and UK parliaments.

Global CGE Models in GAMS:

Global multi-sectoral and multi-regional Models: GLOBE, GLOBE_DYN and METRO

The GLOBE models developed with Scott McDonald and Karen Theirfelder are currently being used

by the OECD and the Institute for Prospective Technological Studies, European Commission's Joint Research Centre (IPTS-JRC).

The METRO model is a supply chain model developed by the OECD. I have incorporated migration, dynamics modules and have incorporated iceberg and willingness to pay methodologies for assessment of non-tariff measures.

Single sector Global Model: R23

The R23 model, developed with Scott McDonald, Karen Thierfelder and Delfin Go, is a new extension to the original 1*2*3 model (by Devarajan, Lewis and Robinson) to cover multiple countries. The model is expected to be made available as part of the World Bank suite of models.

Between 2004 and 2013 I was responsible for managing and leading the Global Trade Analysis Project. This project has an annual core budget of \$1 million, and employs approximately 8 permanent and 3 part time staff and interfaces with a network of 10,000 academic and other researchers. The activities involved include, *inter alia*:

- Managing all the activities, staff and budget of the Center for Global Trade Analysis. Membership of the GTAP network increased from 2,000 members in 2004 to 10,000 in 2013.
